19.01 Park Regulations

(1) Vandalism -

No person shall destroy, mutilate, deface, injure or remove any fence, railing, bridge, building, fountain, seat, sign, pipes, hydrants, walks, drives, curbs, gutters or apparatus or fixed or moveable property of any kind; nor shall injure, break, remove or mutilate any trees, shrubs, plants or flowers in any of the public park pleasure drives or boulevards.

(2) Hunting Prohibited -

No person shall kill, maim or remove any bird or animal in any public park.

(3) Trespassing By Animals -

The owner or keeper of any horse or any other animal that shall trespass upon any of the flowers or flower beds, lawns or property, or do injury to any part of the parks shall be held responsible for such trespass and damage. No person shall air any dogs, whether on a leash or not, in any public park.

(4) Refuse, Etc. -

All refuse, paper or waste material shall be placed in receptacles provided therefor.

(5) Games and Sports -

No person shall play football, baseball or archery in any public park except in and upon such areas officially designated by the Board of Park Commissioners for such purpose.

(6) Motor Vehicles -

No motor vehicle shall be allowed in any park at any time, except by the written permit of the Park President or some one chosen by him as proxy for him. Such permit shall allow the driver of the motor vehicle to enter th park, unload and immediately thereafter leave the park. No motor vehicle shall be allowed to remain in the park, except with the written permit of the Park President or his proxy.

(7) Bicycles -

Bicycles shall be ridden in parks on the park paths only. The riding of bicycle sin any park after 6:00 p.m. during any major activities in such parks, such as ball games, picnics and band concerts, is prohibited.

19.02 Park Hours

No person shall be in any City park between the hours of 11:00 p.m. and 5:00 a.m. of the following day.

19.03 Camping

There shall be no overnight camping in the City.

19.04 Water Regulations

(1) Application -

This section shall apply to the waters of the Sheboygan River and Onion River within the jurisdiction of the City.

(2) State Statutes Adopted -

The statutory provisions describing and defining regulations with respect to water traffic, boats, boating and related water activities in the following enumerated sections of the Wisconsin Statutes are hereby adopted and by reference made a part of this section. Any act required to be performed or prohibited by the provisions of any statute incorporated herein is required or prohibited by this section.

(3) Water Skiing -

No person shall operate a boat for the purpose of towing a person on water skis, aquaplane or similar device or permit himself to be towed for such purpose.

(4) Littering Waters Prohibited -

No person shall deposit, place or throw from any river bank, boat, raft, pier, platform, bridge, or similar structure any cans, paper, bottles, debris, refuse, garbage, solid or liquid waste into the water of the river.

19.05 Control of Vehicular Traffic On Sheboygan River

(1) Permit Required -

During such periods of time as the Sheboygan River flowing within the limits of the City is frozen or partially frozen, all vehicular traffic thereon shall be prohibited unless a permit has first been issued by the City Clerk.

(2) Exceptions -

The above shall not apply to such lawful operation of snowmobiles as has been provided for and permitted by Ch. 7, nor to any City owned and operated vehicles operating on the river while in the performance of normal governmental functions.

19.10 Penalty

Any person who shall violate any provision of this chapter, or any regulation, rule or order made hereunder, shall be subject to a penalty as provided by Section 25.04 of this Municipal Code.
